2. Find the value of $\left|\begin{array}{cc}\sin A & -\sin B \\ \cos A & \cos B\end{array}\right|$, where $A=63^{\circ}$ and $B=27^{\circ}$.
3. Find the angle between $\vec{a}$ and $\vec{b}$ if $|\vec{a} \cdot \vec{b}|=|\vec{a} \times \vec{b}|$.
4. If $f: R \rightarrow R$ is given by $f(x)=\left(5-x^{5}\right)^{\frac{1}{5}}$ then find fof $(x)$.

5. Evaluate $\tan ^{-1}\left[2 \cos \left(2 \sin ^{-1} \frac{1}{2}\right)\right]$.
6. Form the differential equation of family of circles in the second quadrant and touching the coordinate axes.
7. If $y=\sec ^{-1}\left(\frac{x+1}{x-1}\right)+\sin ^{-1}\left(\frac{x-1}{x+1}\right)$ find $d y / d x$.
8. The radius of a circle is increasing at the rate of $0.7 \mathrm{~cm} / \mathrm{sec}$. What is the rate of increase of it's circumference?

11. For 6 trials of an experiment, let $X$ be a binomial variate which satisfies the relation $9 P(X=4)=P(X=2)$. Find the probability of success.
12. Prove that $\vec{a}=(\vec{a} \cdot \vec{i}) \vec{i}+(\vec{a} . \vec{j}) \vec{j}+(\vec{a} \cdot \vec{k}) \vec{k}$.

13. A trust invested some money in two type of bonds. The first bond pays $10 \%$ interest and second bond pays $12 \%$ interest. The trust received Rs. 2800/- as interest. However, if trust have interchanged money in bonds, they would have got RS 100 less as interest. Using matrix method, find the amount invested by the trust. Interest received on this amount will be given to Help Age India as donation. Which value is reflected in this question?
14. Discuss the differentiability of the function $f(x)=\left\{\begin{array}{l}2 x-1, x<1 / 2 \\ 3-6 x, x>1 / 2\end{array}\right.$ at $x=1 / 2$.

Find the value of k so that the function given by

f(x)= \begin{cases}k & \text { if } x=2 \\ \frac{2^{x+2}-16}{4^{x}-16} & \text {, if } x \neq 2\end{cases}
$$

23. If a machine is correctly set up, it produces $90 \%$ acceptable items. If it is incorrectly set up only $40 \%$ items produced are acceptable. Past experience shows that $80 \%$ of the setups are correctly done. If after a certain set up, the machine produces 2 acceptable items, find the probability that the machine is correctly set up.

26. Using integration, find the area of the region by the following curves

\left\{(x, y): 0 \leq y \leq x^{2}+3,0 \leq y \leq 2 x+3,0 \leq x \leq 3\right\}
$$

27. Let $f: N \rightarrow R$ be a function defined as $f(x)=4 x^{2}+12 x+15$. Show that $f: N \rightarrow S$ where $S$ is range of $f$, is invertible. Find the inverse of $f$.

Let * be a binary operation on $\mathrm{Q} \times \mathrm{Q}$ by $(\mathrm{a}, \mathrm{b})^{*}(\mathrm{c}, \mathrm{d})=(\mathrm{ac}, \mathrm{b}+\mathrm{ad})$, where Q is the set of rational numbers. Determine whether * is commutative and associative. Find the identity element for * and the invertible element of $\mathrm{Q} \times \mathrm{Q}$.

29. A company manufacture two type of novelty souvenirs made of plywood. Souvenirs of type A requires 5 minutes each for cutting and 10 minutes each for assembling. Souvenirs of type $B$ require 8 minutes each for cutting and 8 minutes each for assembling. There are 3hrs, 20 minutes available for cutting and 4 hrs available for assembling. The profit is Rs. 5/- each for type A and Rs. 6/- each for type B souvenirs. How many souvenirs of each type should the company manufactures in order to maximize the profit?
