THE INSTITUTE

The Army Institute of Law (AIL) was established in July 1999 by the Indian Army under the aegis of the Army Welfare Education Society (AWES) at its interim location at Patiala. AIL shifted to its permanent campus in Sector 68, Mohali (Pb) in July 2003. It has a magnificent residential campus at Mohali with an impressive architectural structure in the vicinity of Chandigarh and Punjab & Haryana High Court. The Institute is fully residential with boys and girls staying in their respective hostels. AIL Mohali Campus was inaugurated by H.E. Dr. APJ Abdul Kalam, President of India on Dec 1, 2003.

AFFILIATION AND APPROVAL

AIL is affiliated to Punjabi University, Patiala and approved by the Bar Council of India.

LOCATION

The Army Institute of Law is presently located at Sector 68, Mohali at a distance of about 1.5 Kms from Mohali Bus Stand, about 6 Kms from Chandigarh Bus Stand and about 15 Kms from Chandigarh Railway Station.

INTER DISCIPLINARY FIVE YEAR CURRICULUM

BA, LL.B. 5-year Degree course comprising 10 semesters has been adopted with the objective of imparting an all encompassing knowledge of Social Science subjects viz., Literature, Sociology, Economics, Political Science and History at the initial stage. This is advantageous in the study of Law and the students are equipped with a strong base for undertaking professional legal education and training. Students are awarded Degree of B.A. (Law) after the successful completion of their first three years of study. After full five years study of social sciences and law courses, they are awarded the degree of Bachelor of Laws.

MASTER'S PROGRAM AT AIL

The Institute is all set to begin with the Post Graduation Course (LL.M.) for the semester 2011-2012. The Course/Syllabus is on the lines of the Punjabi University, Patiala

AIMS AND OBJECTIVES

To provide practical training and to assist students in job placement on successful completion of Law Course.

To promote sports, co-curricular and extra-curricular activities for overall personality development.

TEACHING METHODOLOGY

The teaching methodology adopted at AIL is intensive as well as extensive class-room teaching involving active participation of the students. Theoretical class room teaching is supplemented by clinical legal work. It also includes preparation of project reports, project presentation, submission of assignments, participation in seminars, Moot Courts and taking tests etc. The students are awarded for their best academic and professional performances.

SPECIAL LECTURES

Modern Legal Education not only requires involvement of Faculty in the class room teaching, but also interaction of the students and faculty with eminent Judges, Lawyers, Social Scientists. To that end, AIL has instituted "Distinguished Lecture Series" where Judges of Supreme Court, High Court, Senior Advocates, Social Scientists and Experts from Law and other allied fields, from India and abroad are invited to deliver lectures and/or to hold interactive Workshop and Seminars on Saturdays.

IN-COURSE ATTACHMENT

To provide maximum opportunity to the students for professional exposure, attachment of the students for practical training with High Court Judges, eminent Lawyers and Law Firms is arranged for a duration of 4-6 weeks for 4th & 5th Year Students and court visits for 1st, 2nd and 3rd Year students. In addition, subject to availability of time, all days in Lawyers chambers at Chandigarh and AIL provides transport facility for the aforesaid attachment.

JOB PLACEMENT OF AIL STUDENTS

AIL provides Job Placement Services through Placement Cell in the Institute.

LIBRARY & COMPUTER LAB

AIL has rich collection of books in a spacious air-conditioned

library. It has text books, reference books, national and international Journals, manuals, periodicals, magazines and newspapers and also e-library section with online facilities. Computer Lab has 50 computers with leased line internet connectivity.

HOSTELS

AIL is fully residential institute with separate boys' girls' hostels. Stay in hostel is mandatory. The Management is planning to install Air-conditioning of the 1st & 2nd floor of the Hostels.

SPORTS & ADVENTURES

The Institute provides indoor and outdoor sports for an overall personality development of the students. These includes basketball, volleyball, badminton, table tennis, chess & carom. Gymnasium provides a wide range of gym equipments. Educational tours aimed at adventure and practical exposure is undertaken preferably for each session depending upon the commitments & college curriculum.

EXTRA CURRICULAR ACTIVITIES

The institute promotes extra curricular activities. Students, as per their interest may become members of the debating Society, Fine Arts Society, Literary Society, Cultural Association, Quiz Association or Moot Court Society and they are encouraged to participate in intra and inter-Institute competitions at AIL India level.

CAMPUS FACILITIES

Banking: Banking service is available with ATM facility to be installed at AIL Campus in near future.

Cafeteria: Provides a variety of eatables to the students with a wonderful ambience.

Generators: To maintain regular supply of electricity at the administrative and academic block, standby generators have been installed.

DTH TV: Available to students in Hostel common rooms.

STD-Booth/Fax/e-mail facility: STD-Booth/ Fax/e-mail facilities etc. are available to students.

Medical Care: Medical facilities are available to the students in the M.I. Room, and wards of Army Personnel can take treatment at Polyclinic Mohali and/or Command Hospital, Chandimandir.

Stationary: There is a fully functional stationary shop which also has gifts, cards as well as recharge coupan for the convenience of the Students.

Wifi: The facility of wifi is available not only in the academic block but also is available in the boys & girls hostels respectively.

Air Conditioning: The college is planning to get the entire academic block inclusive of class rooms Air Conditioned.

SEATS FOR ADMISSION

ADMISSION

Admission to B.A., LL.B. 5 Year Degree Course will be made on the basis of the merit of Entrance Test to be conducted on all India Basis at 16 test centres. A candidate seeking admission to this course is required to send his/her application for the Entrance test in the prescribed form. Weightage is given to wards of gallantry award winners and war widows as per criteria laid by Army HQ (AWES).

ELIGIBILITY FOR ADMISSION

- (a) A candidate who has passed 10+2 examination of the Punjab School Education Board or any other equivalent examination recognized as such by the Punjabi University, Patiala securing at least 45% marks (40% in case of SC/ST candidates) is eligible.
- (b) He/She should not have completed the age of 20 Years.

APPLICANTS APPEARING IN QUALIFYING EXAMINATION

The applicants appearing for the qualifying examination in April are also allowed to take the Entrance Test provisionally, subject to the condition that their candidature shall stand cancelled in case they do not pass the 10+2 Mar/Apr exams with the required percentage of marks by the time of interviews for admission. Compartment cases are ineligible for admission even if they clear the examination in supplementary examination and a seat is available.

Note: Candidates are to give three options for the test centres in order of preference. A test centre is activated subjected to the availability of minimum 15 students, failing which candidate is allotted a centre, opted for in the next order of preference. Centres can change every year for new admission.
